- 1. The stud fee of £1500 is payable as follows
 - a. The non-refundable booking fee deposit of £500 is payable upon signing this Agreement.
 - b. The outstanding balance shall be paid in full prior to any semen being sent to the above mare.
- 2. The mare owner will be covered for a live foal guarantee.
 - a. If the mare aborts or the resulting foal dies within 24 hours the mare owner has the right to a rebreeding
 - b. A veterinarian certificate stating the reasoning for abortion or death of foal must be supplied to MBST within 7 days of abortion or death.
 - c. This certificate must state date of abortion or death.
 - d. If under any unforeseen circumstances the semen is not available stallion owner will refund the outstanding breeding fee.
- 3. Live foal guarantee to stallion shall lapse and the stallion owner and manager shall have no further obligation under section "2"
 - a. Mare owner fails to provide Rhinopneumonitis vaccination certificate.
 - b. Mare is bred by any other stallion without written or verbal consent from MBST prior to rebreeding.
 - c. Mare is substituted with another mare without written or verbal consent by MBST.
 - d. Mare fails to conceive, aborts or dies and mare owner fails to notify MBST as defined under section "2"
- 4. The cost of the semen collection and preparation will be £110 per collection payable upon requesting the semen.
 - a. All Shipment costs are to be paid by the mare owner and will be payable upon requesting the semen.

- b. The mare owner accepts responsibility that the stallion will be showing during the breeding season and it is the mare owners responsibility to check availability during the breeding season.
- c. MBST shall provide semen from the stallion identified in this contract and makes no other guarantee of the condition of the semen once the semen has left the breeding barn.
- d. Mare owner shall request collection 24 hours prior to shipment
- 5. Mare owner shall have the responsibility to ensure proper handling, insemination of the semen into the mare.
